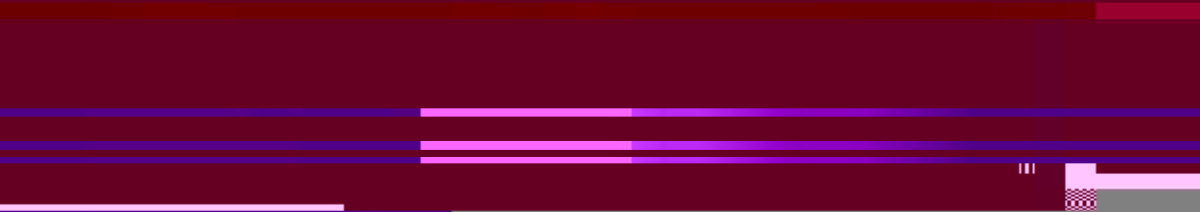

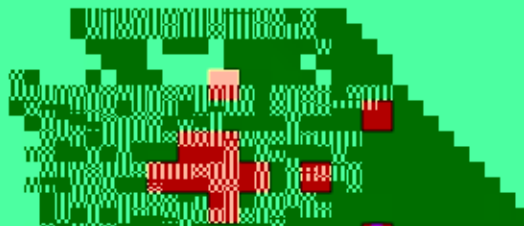
**FY 04 Expenditures**
